Dual Win for IAG Executive Managers with Honourable Governance Award

With Rahul as a finalist for 2021, 2022, 2023 and 2024, and Anthony as a finalist for 2023 and 2024, as well as both being named outstanding achievers for 2023, and now taking out this year's award for joint winner of Governance Top 100 2024," she said.
